10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12	NEW SECTION. Section 1. Continuous eligibility for young children enrolled in healthy		
13	Montana kids plan legislative findings and purpose. (1) The legislature finds that Montana voters		
14	approved a ballot initiative in 2008 to create the healthy Montana kids plan, which coordinated access to health		
15	coverage for children enrolled in the Montana medicaid program and the children's health insurance program		
16	and increased eligibility standards for those programs.		
17	(2) The legislature further finds that fluctuations in family income can result in a child being		
18	disenrolled and subsequently reenrolled in the programs making up the healthy Montana kids plan multiple		
19	times before the child reaches 19 years of age.		
20	(3) The legislature further finds that Montana experienced one of the largest percentage increases		
21	of children losing coverage under the medicaid program and children's health insurance program during the		
22	recent eligibility unwinding, and, as a result, large numbers of uninsured children are eligible but not enrolled in		
23	the medicaid program and the children's health insurance program.		
24	(4) The legislature further finds that pediatrician-recommended checkups are more frequent in the		
25	earliest months and years of a child's life to monitor developmental milestones and address small complications		
26	before they become complex conditions.		
27	(5) The legislature further finds that <u>3 YEARS 1 YEAR OF</u> continuous eligibility FROM THE DATE OF		
28	INITIAL ENROLLMENT OR SUBSEQUENT REENROLLMENT for healthy Montana kids plan enrollees under 6 years of

2 will provide consistent, predictable access to health care services at a time of critical early (a) 3 childhood development;

4 (b) will improve health outcomes by providing children with ongoing preventive care and by 5 preventing gaps in care that can occur when a family loses coverage and cannot afford necessary health care 6 services, including medications;

7 may reduce the costs of health care services by allowing children to receive the right level of (C) 8 care at the right time in the right setting and by lessening the chances that they will need emergency care or 9 treatment for conditions that have worsened because of a lack of care; and

10 (d) may improve a child's readiness for school because regular, preventive care may identify

11 physical, behavioral, and developmental concerns that can be addressed before the conditions affect school 12 performance.

13 (6) The legislature further finds that providing 3 YEARS-1 YEAR OF continuous eligibility until the child

14 reaches-FROM THE DATE OF ENROLLMENT OR REENROLLMENT FOR A CHILD UNDER 6 years of age will reduce

15 administrative costs for the department of public health and human services by reducing the need to

16 redetermine a child's eligibility for renewed or continued coverage under the healthy Montana kids plan.

17 (7) It is the purpose of the legislature to allow a child UNDER 6 YEARS OF AGE enrolled in the healthy

18 Montana kids plan to remain CONTINUOUSLY enrolled in the program until 6 years of age FOR 3 YEARS 1 YEAR

19 FROM THE DATE OF INITIAL ENROLLMENT OR REENROLLMENT, OR UNTIL THE CHILD REACHES 6 YEARS OF AGE.

20 WHICHEVER OCCURS FIRST, even if a change in family circumstances occurs that would otherwise make the child 21 ineligible for the program.

(8) 22 The department of public health and human services may conduct audits to ensure compliance 23 with this section.

24 (9) The legislature directs the department of public health and human services to apply to the 25 centers for medicare and medicaid services for the necessary waivers and state plan amendments to allow for 26 3 YEARS 1 YEAR OF continuous eligibility as provided in this section for children enrolled in the programs making 27 up the healthy Montana kids plan through the end of the month in which a child attains 6 years of age. Among 28 other elements, the department's research and demonstration waiver applications must include but are not

2	(a)	whether ongoing enrollment will:	
3	(i)	reduce the percentage of children under 6 years of age who are disenrolled and reenrolled in	
4	the programs making up the healthy Montana kids plan;		
5	(ii)	increase the number of enrollees participating in well-baby and well-child visits, including	
6	developmental assessments to the extent those assessments can be quantified; and		
7	(iii)	increase access to early intervention or other services that can prevent or lessen	
8	developmental delays before kindergarten; and		
9	(b)	whether continuous eligibility will reduce administrative costs for the department.	
10	(10)	The department shall:	
11	(a)	submit requests for the necessary waivers and amendments required under subsection (9) no	
12	later than July 1, 2025;		
13	(b)	notify the appropriate interim or standing committees of the legislature when the department	
14	has received a decision from the centers for medicare and medicaid services on a waiver or amendment		
15	request and include a copy of the decision with the certification. The department shall submit the notification		
16	within 30 days from the date the decision is received and shall submit a copy of the notification to the code		
17	commissioner.		
18	(C)	if the necessary waiver and amendment requests are approved, implement $\frac{3 \text{ YEARS-1 YEAR}}{2 \text{ OF}}$	
19	continuous eligibility for eligible children no later than 6 months from the date the approval from the centers for		
20	medicare and medicaid services is received by the department.
