Description of fiscal impact

HB 234 extends the lead reimbursement program that the Department of Environmental Quality (DEQ) administers to reimburse schools for the costs with complying with the Department of Public Health and Human Services (DPHHS) lead in school rule. The bill also re-appropriates the unexpended balance of the appropriation authorized by the 2023 Legislature for the Lead in Schools Program.

FISCAL ANALYSIS

Assumptions

Department of Environmental Quality

1. DEQ projects a program balance of \$3,531,548 at the end of fiscal year 2025, when the appropriation sunsets.
2. DEQ will receive expenditure reimbursement requests consistently through the next four years.
3. DEQ will not receive any additional reimbursement requests in FY2025.
