### Description of fiscal impact

HB 372 increases several hunting license prices and increases the revenue earmarked for the Upland Game Bird Enhancement Program.

### FISCAL ANALYSIS

#### Assumptions

#### Department of Fish, Wildlife, and Parks

1. HB 372 as twice amended increases the Class B-1 Nonresident Upland Game Bird license price from \$110 to \$127 beginning in LY 2026. HB372 also changes the earmarked amount that is distributed to the Upland Game Bird fund from \$23.00 to \$40.00 and exempts the nonresident relative of a resident (NRROR) B-1 licenses from the earmarked distribution. Based on LY 2023 sales, this would create an increase in revenue of \$138,184.50/year. The following table shows the change in revenue by fund:

2. HB 372 as twice amended increases the price of a Class B-2 3-Day Nonresident Upland Game Bird license from \$50 to \$60 beginning in LY 2026. HB 372 also changes the earmarked amount that is distributed to the Upland Game Bird fund from \$10.00 to \$20.00. Based on LY 2023 sales, this would create an increase in revenue of \$34,900/year. The following table shows the change in revenue by fund:

HB 372 as twice amended changes the price of a Class B-10 Nonresident Big Game Combination license from \$1,278—as currently adjusted by the consumer price index (CPI) allowed by statute—to \$1,312 beginning in LY 2026. HB 372 also changes the earmarked amount that is distributed to the upland game bird fund from \$23.00 to \$40.00 and exempts half-priced B-10 licenses—for youth, college students, and applicants who qualify for the NRROR and Come Home to Hunt half-priced licenses—from the earmarked distribution. Based on LY 2023 sales, this would create an increase in revenue of \$430,389/year. The following table shows the change in revenue by fund:

HB 372 as twice amended changes the price of a Class B-10 Nonresident Elk Combination license from \$1,078—as currently adjusted by the consumer price index (CPI) allowed by statute—to \$1,112 beginning in LY 2026. HB 372 also changes the earmarked amount that is distributed to the upland game bird fund from \$23.00 to \$40.00 and exempts half-priced B-10 licenses—for youth, college students, and applicants who qualify for the NRROR and Come Home to Hunt half-priced licenses—from the earmarked distribution. Based on LY 2023 sales, this would create an increase in revenue of \$179,605/year. The following table shows the change in revenue by fund:

HB 372 as twice amended changes the price of a Class AAA Combination Sports without a bear license from \$62 to a \$64.50, beginning in LY 2026, and a Class AAA Combination Sports with a bear license from \$77.00 to a \$79.50. HB 372 also changes the earmarked amount that is distributed to the Upland Game Bird fund from \$2.00 to \$4.50, and exempts half-priced AAA licenses—for youth, and senior residents—from the earmarked distribution. Based on LY 2023 sales, this would create an increase in revenue of \$173,318.75/year. The following table shows the change in revenue by fund:


