Description of fiscal impact

General Fund Balance

HB 643 as amended updates the definition of "actual cost" of a detention center to be the greater of the daily per inmate provider rate for an operator of a private correctional facility in Montana with a population of more than 500 state inmates that contracts with DoC less 10% or \$82.00. The amendment also directs the Department of Public Health and Human Services (DPHHS) to utilize the \$6,000,000 state special appropriation to reimburse counties at a rate equal to 135% of the rate paid to private contracted facilities with more than 500 state inmates. DPHHS will incur costs related to reimbursing counties.

FISCAL ANALYSIS

Assumptions

Department of Corrections (DoC)

1. The rate for DoC does not change, given the amendments to the bill so there would be no fiscal impact.

Department of Public Health and Human Services (DPHHS)

- 2. Section 2(2) directs DPHHS to reimburse counties at 135% of the rate paid to operators of private correctional facilities in Montana with greater than 500 state inmates.
- 3. The daily rate paid by DPHHS would be \$133.88 in FY 2026, with a 1.5% growth each year.
- 4. The department's waitlist averages 100-125 people held daily in county detention centers while awaiting placement into a DPHHS facility. The waitlist is assumed to hold at 125 for the projected years.
- 5. Based on the assumptions above, the department assumes the \$6 million state special appropriation in Section 2 will be exhausted in FY 2026 (see table after assumption 5).
- 6. Total costs are \$6,108,197 in FY 2026, \$6,199,820 in FY 2027, \$6,292,817 in FY 2028, and \$6,387,209 in FY 2029 (table below). Costs in excess of the appropriation are shows as general fund in this analysis.

Technical Concerns

Department of Corrections

1. There is an amendment being proposed to HB 913, which is the Section D companion bill. It appears the amendment will also establish a daily rate of \$85.30 for detention centers. The language would appear to conflict with the language in HB 643 so coordinating language between the bills may be needed.

Department of Public Health and Human Services

- 1. The department currently has requests for HB 2 decision packages that may reduce the waiting lists at the detention center.
- 2. The Behavioral Health Systems for Future Generations (BHSFG) fund was established to expand intensive and community-based behavioral health and developmental services across Montana.
- 3. The bill lists the minimum daily per-inmate provider rate as \$82.00, which could change depending on the passage of other legislation.
- 4. The language in Section 2(2) is could be interpreted to mean that the 135% rate only applies to counties which contain a private correctional facility housing more than 500 state inmates. Amendments to provide clarification may be needed.
