#### Description of fiscal impact

HB 732 directs the Department of Public Health and Human Services (department) to align cost settlement procedures for Critical Access Hospitals (CAH) with those used by Medicare. Additionally, the bill requires the department to address the backlog of CAH experiencing delays in their final Medicaid settlements due to Medicare audits.

### FISCAL ANALYSIS

#### Assumptions

##### Department of Public Health and Human Services

1. The department estimates that there will be additional expenses to amend the current contract with the regional designated Medicare administrative contractor (MAC) to calculate interim payments for a backlog of CAHs currently experiencing delays in their final Medicaid settlements due to Medicare audits and establish annual interim settlement reviews alongside the final reviews.
2. The estimate provided by the department's vendor is a one-time operations expense to address the backlog of \$52,800, and an ongoing cost of \$15,000 annually.
3. These costs are Medicaid administrative services that receive Federal Medical Assistance Percentage (FMAP) of 50% general fund and 50% federal funds.
4. CAH cost settlements are typically budget neutral. Through the cost settlement process, the department reimburses CAHs determined to be underpaid and recoups funds from those who have received overpayments. As a result, there will be no fiscal impact to the department aside from the costs associated with the contract.
