### **Description of fiscal impact**

HB 803 provides a process that only applies to individuals bringing private claims related to asbestos exposure health effects; the defendants in those actions; and asbestos trusts set up to pay out health claims. This bill does not apply to NRDP's Libby Asbestos settlement fund (specific to natural resource damages) or any future natural resource damage settlements that may be received. There is no fiscal impact to the state.

### **FISCAL ANALYSIS**

#### **Assumptions**

#### **Department of Environmental Quality**

1. HB 803 is regarding civil litigation and sets out the disclosures that a plaintiff must make to the defendant and the court in an asbestos trust claim. DEQ funds obtained through bankruptcy negotiations are limited to the Libby superfund site to address operations and maintenance of the remedy and cannot be used to compensate individuals for health-related impacts.
2. DEQ does not receive claims related to health effects of exposure to asbestos.

#### **Department of Justice**

3. This bill has no fiscal impact on the Natural Resource Damage Program (NRDP) because the bill provides a process that only applies to people bringing private claims related to asbestos exposure health effects; the defendants in those actions; and asbestos trusts set up to pay out health claims. This bill does not apply to NRDP's Libby Asbestos settlement fund (specific to natural resource damages) or any future natural resource damage settlements that may be received.
