Description of fiscal impact

SB 392 establishes the Laverne Parrish memorial highway on the existing state highway 93 from mile marker 48 to mile marker 53.

FISCAL ANALYSIS

Assumptions

Department of Transportation

- Two signs are needed on state highway 93 at mile marker 48 and mile marker 53 north of Ronan.
- The Montana Department of Transportation's (MDT) Maintenance program employees will design, fabricate, and install the two signs.
- Signs must conform to the Manual on Uniform Traffic Control Devices (MUTCD).
- The cost per sign for labor, materials, and installation would be \$1,658.
- The total cost for two signs to be installed on state highway 93 would be \$3,316 (2 x \$1,658.00 = \$3,316.00).

Technical Concerns

Department of Transportation

1. US 93 has two locations with mile markers 48 and 53, North of Hamilton and North of Ronan.
2. In 2010, the Director of MDT designated the Montana Highway Patrol Trooper Christopher L Hoyt Memorial Highway on state highway 93 from mile marker 51.8 to 56.5. SB 392, establishing the Laverne Parrish memorial highway, on state highway 93 between mile marker 48 and 53 would overlap the existing Christopher L Hoyt memorial highway designation.
