Description of fiscal impact

SB 430 revises laws relating to civil commitment and emergency detention of mentally ill persons, including conditions for transport to the Montana State Hospital and actions constituting contempt of court. The amendment requires that the professional person completing the emergency evaluation of the person placed in custody pay a \$20 fee to the court when the report is filed.

FISCAL ANALYSIS

Assumptions

Judiciary

1. SB 430 revises actions that may be considered contempt in a court to ensure that the refusal or inability to admit a person who has been ordered to be committed to the Montana State Hospital under certain circumstances may not be considered in contempt.
2. SB 430 relates to civil commitments under Title 53, Part 21 where the costs related to commitment and evaluation of the mentally ill are not the responsibility of the Judicial Branch, but of the county of residence.
3. Section 6 requires a \$20 filing fee to be paid to the court before a professional person may file a report related to an emergency commitment.
4. The Judicial Branch does not collect court fees. The Department of Revenue collects court fees through the county collection process. The Judicial Branch assumes the fees will be deposited in the general fund in accordance with 25-1-202, MCA, although the amount of fees are not known, but are anticipated to be de minimus.
5. There are no costs related to the district court or the Judicial Branch as a result of this bill.

Department of Public Health and Human Services (DPHHS)

6. This amendment adds a \$20 fee to be collected by the court through the county collection process.
7. There is no impact for DPHHS.
