Description of fiscal impact

SB 50 requires a warrant to remove a child from the family unless the child is likely to experience sexual abuse or serious bodily injury in the time that would be required to obtain a warrant. The Department of Public Health and Human Services (DPHHS) Child and Family Services Division (CFSD) will incur additional overtime hours for child protection specialists (CPS) to secure warrants prior to removal, as well as costs to train current CFSD staff and county personnel on the new requirements and processes.

FISCAL ANALYSIS

Assumptions

Department of Public Health and Human Services (DPHHS)

- SB 50 requires a warrant to remove a child from the family unless the child is likely to experience sexual abuse or serious bodily injury in the time that would be required to obtain a warrant. There were 1,276 removals during FY 2024. Of the 1,276 removals during FY 2024, 86% would require a warrant with the passage of SB 50. It is estimated to require two hours of child protection specialist (CPS) staff time to write a warrant and five hours to wait for the warrant to be issued. It is estimated that the warrant process will occur at an average of \$59.22 per overtime hour cost of CPS staff (1,097 FY 2024 removals, times 86% requiring a warrant, equals 1,097 warrant removals; two hours of warrant writing time, plus five hours warrant processing time, equals seven hours per warrant; 1,097 warrant removals, times seven hours per warrant, equals 7,679 annual hours of additional CPS time; 7,679 annual hours, times \$59.22 average hourly cost, equals \$454,750).

2. Warrant writing will be a new process for DPHHS staff. Applicable DPHHS Child and Family Services Division (CFSD) staff will require training on the warrant writing process that will require development. Additional warrant writing training will be provided to 331 current employees across multiple staff types and take four hours at an average hourly cost of \$39.54. The warrant writing training will be incorporated into new employee training in FY 2027 and beyond. (Four hours of training, times 331 current CFSD employees, times \$39.54 average hourly employee cost, equals \$52,351).
3. CFSD will facilitate warrant writing training to law enforcement and judges in all 56 Montana counties. The warrant writing training will take four hours at a rate of \$49.66 per hour. (56 counties, times four hours of training, times \$49.66 per hour, equals \$11,124).
4. CFSD administrative expenditures are federally allowable expenditures under Title IV-E of the Social Securities Act at a federal participation rate of 30%, the remaining 70% of expenditures are funded with State General Funds.

Public Defender (OPD)

5. OPD assumes no impact from the shortened time to file abuse and neglect petitions as OPD does not file such petitions.
6. OPD assumes no impact from the warrant requirement as OPD does not remove children and would not be responsible for preparing such warrant applications.
7. OPD assumes no impact relating to OPD's coverage of EPS hearings as SB0050 as written does not shorten the allowed time between OPD's appointment to these cases upon a petition's filing and the resulting EPS hearing.
