Description of fiscal impact Department of Transportation

Senate Bill 59 establishes the Staff Sergeant Arthur J. Rambo memorial bridge on existing state Highway 37.

FISCAL ANALYSIS

Assumptions

Department of Transportation

- 1. Two signs and a memorial plaque will be installed on state Highway 37 near the Kootenai River bridge.
- 2. The Montana Department of Transportation's (MDT) Maintenance program employees will design, fabricate, and install the two signs and the plaque.
- 3. Signs must conform to the Manual on Uniform Traffic Control Devices (MUTCD).
- 4. The cost per sign for labor, materials, and installation would be \$1,657.50.
- 5. The cost to design, fabricate, and install the plaque would be \$2,685.
- 6. The total cost for two signs and a plaque to be installed near the Kootenai River bridge is 6,000 (2 x 1657.50 + 2685).
